This article includes a unique circuit, devised by KA9DDN, and some information gathered by WB9RQR in his efforts to understand how to treat the little box hanging from the bottom of his new HT. We hope it will be of use to you.

Your HT nicad battery pack contains a number of individual nickel-cadmium cells which may be recharged many times. How many cells are there in that sealed pack? This is easily determined, as follows. Nicad cells measure a no-load voltage of 1.4 volts, immediately after a full charge, which drops off to 1.35 volts an hour after charge. To determine how many cells are present, simply charge the pack fully according to the instructions and measure the voltage, immediately. Divide by 1.4 and round your answer to the nearest whole number. Are all of the individual cells in the pack good? Again, easy to determine, provided you can do without the pack for a time. Fully charge the pack and put it on the shelf for 2 to 3 days. Again measure voltage. If the pack shows at least 1.3 volts per cell, it is fine. If the voltage has decreased by multiples of 1.2 to 1.3 volts, the whole number multiple represents the number of bad cells in the pack. Note that these values hold at room temperature only (20°C, 68°F).

Your battery pack (and each cell within it) is rated in milliampere-hours. For example, the small BP-3 pack which comes with the ICOM 2AT contains seven cells, each rated at 250 maH. Each cell will provide 250 ma for one hour. Of course, these are in series to provide enough voltage, so the whole pack will also provide 250 ma for one hour. When dealing with charging, it is common to consider current rate (C); the value of current rate is the same as the milliampere rating of the battery pack or cell.

There are three commonly accepted rates to pump new life into nicads. These are standby or *trickle* charging, slow or *overnight* charging, and quick or *fast* charging. The table below shows how these are related.

		HOURS TO RECHARGE
NAME	<u>C</u>	AT 25°C (77°F)
Fast	0.3	3 - 4
Overnight	0.1	14 - 16
Trickle	0.01	200 May 100 Ma

Note that the trickle rate is only designed to maintain a full charge while the battery is not being used; repeated charging at less than 0.1C will cause the battery capacity (milliampere-hours) to fade. Note also that the fast charge rate can be safely used with conventional nicads, provided that the ambient (surrounding) temperature is above 15°C (or 59°F; lower temperatures alter the desired chemical reactions during charging), and provided the battery case temperature does not exceed 45°C (113°F). The latter can easily be tested with your hand during the charging period.

For a 250 maH pack such as the small one (BP-3) which comes with the ICOM 2AT, the ideal charging rates would be: fast charge (0.3C) = 75ma for 4 hours; overnight (0.1C) = 25ma for 15 hours; trickle (0.01C) = 2.5ma for as many hours, days or weeks that the battery is not in use. For a 450 maH pack the values would be: 0.3C = 135ma, 0.1C = 45ma, 0.01C = 4.5ma. One word of caution. If you are fast charging a pack, do not exceed the 4 hour time period. If you forget and leave it on overnight, you may well find a puddle of melted plastic and metal in the morning. Even worse, the pack may explode!

So much for the theory! Now that you know you can safely fast charge that pack, how about a gadget to do it? Here is a versitile charger, low in cost,


that can be used with individual cells or a battery pack, and that will regulate current at the desired level. It is a simple circuit, using two IC's. The first, a 7818, regulates well filtered DC at 18 volts. This should be the value you measure at the large arrow in the diagram below. The second IC, a 7805, is the unique part of the circuit. Although this is a 5 volt 3 terminal regulator, in this circuit it is used to regulate current rather than voltage, the level of which is set by Rl. Rl can be a single, fixed resistor, which limits current according to Ohm's law, as follows:

	Rl	CURRENT
	10 ohms	500 milliamperes
	33.3	150
(I = E/R)	50	100
	100	50
	200	25

Alternatively, Rl can be switch-selected, permitting several levels of current output. Even more handy would be a variable resistor. However, if you use a pot, be sure it is a hefty one or you may burn it out (WB9RQR "smoked" three before settling on a 2 inch diameter vitreous enamel model). Also, if you use a pot, it might be a good idea to insert a fixed resistor of 10 ohms or so in series with it, which will limit current to 500 ma when the pot is turned all the way down to zero resistance. This will protect the IC's from going up in smoke if you turn on the supply with a load connected, and the pot is set for maximum current. You might consider also using a value other than 10 ohms, in keeping with the maximum value of current you wish to pump into the battery pack. A milliammeter is also convenient, especially if you use a pot. Break the circuit at the small arrow and insert a 0-500ma meter (if the circuit is built to reach 500ma maximum current).

Note that this is a *floating* supply; if you use a metal case, no connections should be made to the case. Capacitors C2 through C5 serve bypass functions, and stabilize the IC's. It is best to solder them directly to their respective IC terminals, or at least keep them close.

One final note. If a meter is in the circuit so that you can monitor the charging rate, you may see a decrease in the charge rate toward the end of the charge cycle, depending upon your particular nicad pack voltage and the charge rate you select. Don't worry about it. It is normal. HAPPY CHARGING.

#### REPEATER REQUEST DENIED


A letter from Federal Commissions Communicator Marvin Larpsnog received last month stated that the Ozaukee Club's request for repeater site change had been reviewed and was denied. Larpsnog stated that while the Club's technical plan to put up an earth orbiting repeater platform was an interesting idea, the FCC would not permit moving WR9AAE to the plat-He further stated that the Club must now take the satellite down before somebody gets hurt. The O.R.C. satellite had been circling the earth once every ninety minutes at an altitude of nine feet. This altitude had been chosen by the repeater technical committee to circumvent NASA and FAA regulations but after a few orbits, it was obvious that the satellite had been collecting debris and would soon be unuseable.

The arrival of the letter caused no concern for the club however. "We had already taken it down and used it for parts for the cornroast charcoal grills", said a Club spokesman, "and besides, the present repeater site is hard enough to get to for making repairs!". AA9W

#### WHAT ARE X-RAYS AND GAMMA RAYS

X rays, gamma rays, visible light, radiowaves, and others are energy waves of electric and magnetic influence. They are called electromagnetic waves and travel at the speed of light, about 180,000 miles per second. Electromagnetic radiation is grouped according to its wavelength in what is called the electromagnetic spectrum. The illustration on the following page shows the uses of various wavelength electromagnetic radiation and where they fit in the electromagnetic spectrum.

X rays can affect photographic film and since they can penetrate most materials they have practical importance. If the material varies in its ability to absorb (stop) x rays, as does human tissue, the film image can show the relative size and location of the different materials penetrated. Interpretation of these images requires the skill of a radiologist or dentist.
